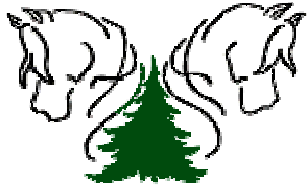

If you are entered in Timed Cones (#15, 16, 17) or Hazards (#18, 19, 20) you must report to the side field within the specified time. Please find a way to do this in among your ring and dressage classes.

GENERAL INFORMATION

- **REQUIRED: Proof of Rabies within one year. Proof of negative Coggin's within 3 years in state and 1 year out of state. This is an absolute requirement – NO EXCEPTIONS!**
- Pleasure, Reinsmanship, and Cones classes will count toward NCRC driving year-end awards. (must be an NCRC member before classes begin to count)
- Classes will ask for a walk, working trot, slow trot, strong trot, halt, and rein back. Gaited classes will ask for walk, slow gait, strong gait, halt, and rein back.
- Open – open to all horses and ponies
Novice – open to horses and ponies who are new to driving, or to drivers with less than two years showing experience
Juniors – open to drivers 18 and under as of Jan 1, 2008. Drivers 14 and under MUST be accompanied in the carriage by a knowledgeable adult horseman.
Mini – open to miniature horses only
- Drivers may enter any or all of the dressage classes. You MUST pre-register for dressage tests before June 14. Times will be available the Thursday before the show, June 19 on our website, www.dexterridingclub.com. Or you may call Angela Coy at 207/343-0033 from 9AM – 8PM or email angie@infinityfarm.us.
- This is not an ADS sanctioned competition; however, it will be based on ADS rules.
- Wire Wheel/Pneumatic vehicles permitted in main ring classes only.
- All drivers must carry a whip at all times and wear gloves.
- A Safety Check will be done on all horses and vehicles prior to entering any classes. If either the harness or vehicle is deemed unsafe then the problem must be corrected before entering any classes.
- Helmets are required in the cones and hazards and permissible in all pleasure and dressage classes.
- A navigator is required in the hazards and must wear a helmet.
- Only trotting or alternate gaits allowed in cones and hazards, no cantering.
- Lunch will be available on site.
